The Jean Monnet Project “Enhancing the Debate about Intercultural Dialogue, EU Values and Diversity” of the University of Macedonia in collaboration with the Jean Monnet Centre of Excellence “European Constitutionalism and Religion(s)” of the Aristotle University of Thessaloniki organized a **Summer Seminar** from the 30th of June until the 3rd of July entitled “**Challenges for the European Societies**”. The summer seminar lasted 27 hours and awarded, after a multiple choice examination, 3 extracurricular ECTS.

The seminar was addressed to a broad audience, including legal practitioners, researchers in EU studies, academics, students of economic, legal and political disciplines, local, regional and national authorities, opinion leaders and the civil society.

The speakers of the seminar were distinguished university professors, academics, researchers, and lawyers.

The seminar addressed several of the most contemporary challenges of the social, economic and political landscape of Europe. It aimed at providing learners with a critical overview of the societal challenges of human trafficking, migration and asylum on different perspectives as well as the economic ideologies that prevail in the European societies. Participants also had the chance to exchange views and experiences regarding citizen participation, human rights, justice and the rule of law, diversity including ideas on best practices.

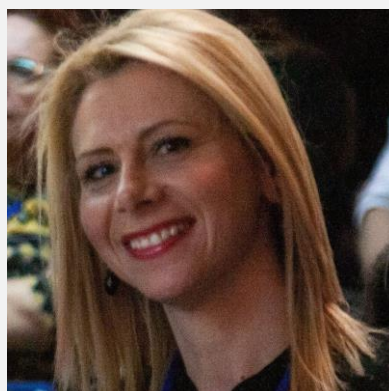
