# First Guest Lecture Event of the EU Security Watch spot

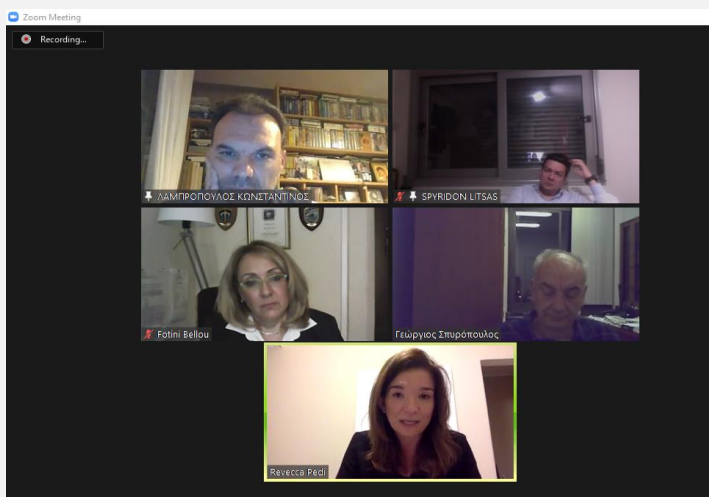
## Contemporary security issues in Europe: Revisionism, Identities, Asymmetric Threats and Power Relations

FRIDAY, OCTOBER 23, 2020

The EU Security Watch Spot of the Jean Monnet Project "Enhancing the Debate about Intercultural Dialogue, EU Values and Diversity" of the Department of International and European Studies of the University of Macedonia organized with great success its first virtual Guest Lecture Event, on "Contemporary security issues in Europe: Revisionism, Identities, Asymmetric Threats and Power Relations" on 23rd of October 2020.

The Keynote Speaker was Dr. Konstantinos Lambropoulos, Senior Strategic Analyst and Partner of the Geneva Center for Security Studies, who spoke about security in Europe, asymmetric threats and power projections. A roundtable discussion followed with a number of academics from the Department of International and European Studies who discussed various angles of international security. More specifically, Professor Georgios M. Spyropoulos focused on the extended nature of international security, Professor Spyridon M. Litsas discussed security and power in the Eastern Mediterranean as well as notions related to climate change and their effect on security, Assistant Professor Revecca Pedi, presented security issues of small states of the European Union, and, finally, Assistant Professor Fotini Bellou, Head of the EU Security Watch Spot, looked at the conditions under which European security has become the victim of an evolving revisionism.

The event was organized in Greek and was attended by more than 300 university students, military personnel and subject matter experts. The discussion that followed with the audience highlighted the importance of key EU policy areas, such as security and defence. It also emphasized the need for continued academic interest and research in order clarify a number of uncertainties and to shed light on the important questions pertaining European security.

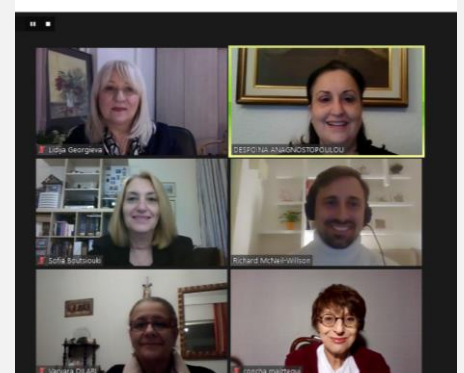
The Jean Monnet Project "Enhancing the Debate about Intercultural Dialogue, EU Values and Diversity" of the University of Macedonia organized a 2-day E-Conference entitled "The role of intercultural dialogue in managing diversity in Europe", on November 18 and 19, 2020 from 16.00 to 21.00 via the Zoom Platform, in collaboration with the UNESCO Chair in Intercultural Policy for an Active Citizenship and Solidarity of the University of Macedonia. The event was a great success with 327 unique users during the first day and 289 during the second day.

The first session was entitled "*Intercultural and Interreligious Dialogue in Europe - EU Citizens and the Others*". ### Intercultural Dialogue as a European Project

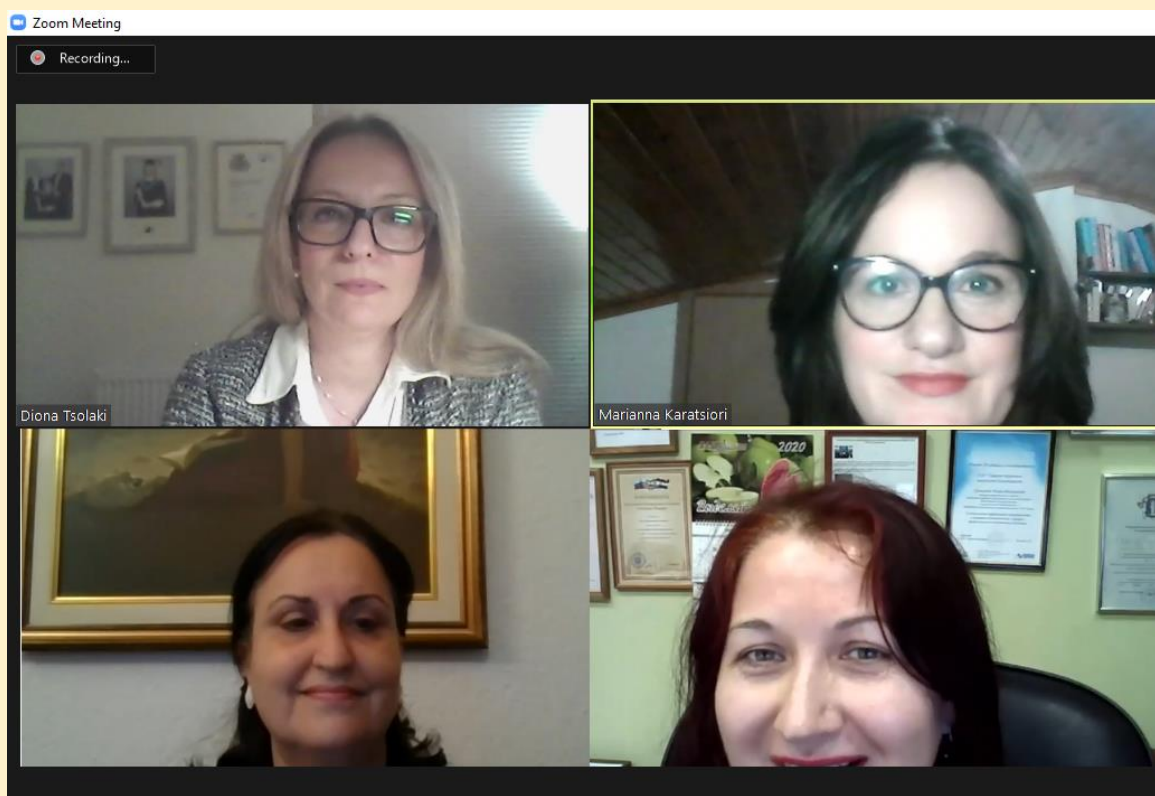

The Jean Monnet Project “Enhancing the Debate about Intercultural Dialogue, EU Values and Diversity” of the Department of International and European Studies of the University of Macedonia has organized the 25 hour - Online Seminar entitled “Intercultural Dialogue as a European Project” on Monday November 16, 23 and 30, 2020 as well as December 7 and 14, 2020 from 17:00 to 21:00 Athens Time. The seminar is co-organised with the UNESCO Chair of Intercultural Policy for an Active Citizenship and Solidarity of the University of Macedonia.

The first three sessions of the Seminar have already taken place with 295 unique users on the 16<sup>th</sup> of November, 294 unique users on the 23<sup>rd</sup> of November and 262 unique users on the 30<sup>th</sup> November.

The topics of the first session on November 16, 2020 were Intercultural Dialogue in the EU, Intercultural Dialogue as a Bridge between the EU and Russia, The Conditions of Intercultural Dialogue: Fundamental Rights, Democracy, Pluralism, Equality, and Intercultural Dialogue after COVID-19 and the George Floyd Tsunami presented by **Despoina Anagnostopoulou**, Associate Professor, Department of International and European Studies, University of Macedonia, Academic Coordinator, Jean Monnet Project EUVaDiS, Thessaloniki, Greece, and **Iulia Sushkova**, Dean, Professor, Law Faculty, Ogarev Mordovia State University, Saransk, Russia, Jean Monnet Chair holder.
